117th Congress

The recent 117th Congress held in Williamsburg, VA was a total success! Over 500 delegates and guests were in attendance to include approximately 100 first time attendees and were afforded the very best of Southern Hospitality. The venue at Williamsburg with the close proximity of both the Yorktown battlefield and Jamestown could not have been a better setting to reflect the historical interests of the Sons of the American Revolution. The high light of the event was the Wednesday night formal banquet which saw Bruce Wilcox (VASSAR) installed as our new President General. For those who might not know, the SAR owns a ring worn by George Washington which was endowed to the society several years ago. During the installation program the ring is placed on the finger of the new incoming President General, albeit for a very short time, before it is returned to the society's vault. Each outgoing PG is presented with a copy of the ring to wear permanently.

The ALSSAR was well represented at the meeting with 12 compatriots and 8 wives in attendance. Larry Cornwell was installed as our new National Trustee and Jim Alexander took over as the Alternate Trustee. At the same time our own chapter member John R. Wallace (in white tie, gloves and tails - rumor has it that John is looking for a part time job as the doorman at Burger King!) was sworn in as the new Vice President General of the Southern District. His duties will include serving as a liaison between the four states of the district and the president general along with representing the Southern District at events both within the district and in other areas of the country. This position rotates among the four states of the district so only comes to Alabama every four years.

The composition of national committees and chairmen will be announced in a couple of weeks, and it is anticipated that the Alabama Society will be well represented on many of the national committees.

Attendance at a national meeting, be it a Congress or one of the Leadership meetings in Louisville, is an ideal way to learn about our great society, meet our leadership and make new friends from around the country. Everyone is strongly encouraged to consider attending the Fall Leadership meeting in Louisville in late September.

Why the CAAH is so Important

We all realize that one of the primary goals of the Sons of the American Revolution is to preserve our history along with keeping alive the story of our patriot ancestors who gave us the liberties we all enjoy today. The following editorial, written shortly after the 4th of July from *The Record*, Bergen County, NJ provides a rather sad commentary on the preservation of our patriotic history.

"In December 1776, a few months after the Hopewell farmer John Hart signed the Declaration of Independence, Hessians sacked his farm and the 63 year old went into hiding in the cold Hunterdon County woods. He died less than three years later, too early to know how the war or the American Experiment would turn out. We who do should recognize his contribution.

...Hart's grave and those of four other signers—Abraham Clark, George Clymer, Richard Stockton and John Witherspoon—lie with the state's borders (ed. NJ), offering opportunities for reflection on our national heritage and principles. These historic places may not be quite as exciting as the pyrotechnics of a few days ago, but they should at least be well marked and maintained.

However, some of these sites lack appropriate markers or bear plaques that have themselves become historical, with faded letters and limited information. A bill that would dedicate \$200,000 to the task of maintaining the graves of the signers has failed to make it out of the state Legislature for three years....

In our minds, this cause ranks above many others that somehow got a piece of the state budget that the governor signed last month..."

Early in 1776, the New Jersey delegation to the Continental Congress was opposed to independence from Great Britain. As the issue heated up, the state convention replaced all their delegates with those favoring the separation. Because Abraham Clark was highly vocal on his opinion that the colonies should have their independence, on June 21, 1776, they appointed him, along with John Hart, Francis Hopkinson, Richard Stockton, and John Witherspoon as new delegates. They arrived in Philadelphia on June 28, 1776, and signed the Declaration of Independence in early July.

George Clymer was one of the first Patriots to advocate complete independence from Britain and was a signatory of the Declaration of Independence as a Pennsylvania representative. He is buried in the yard of the Friends Meeting House in Trenton, New Jersey.

This apparent indifference by a state legislature to the final resting places of individuals who signed one of the most important documents in the world, is yet another reason we all needed to become involved in assuring that our new Center for Advancing America's Heritage is fully funded and built as soon as possible. Through expanded outreach education the SAR can raise the awareness of our national history, and the roles played by not only those named above, but all patriots in founding this great nation.

Only two things are infinite, the universe and human stupidity, and I'm not sure about the former.
