FLAG CERTIFICATES

The National Society has a program, via a Flag Certificate, to recognize individuals, companies,

and government agencies that fly the United State flag for patriotic purposes. It is not intended for those commercial enterprises that obviously fly the flag for advertising reasons. At the same time, the State Society is eligible to receive *The Admiral William R. Furlong Memorial Award*, if the state society and the majority of its chapters present, during the previous year, at least one NSSAR Flag Certificate to a person or organization who qualified. This award is in the form of a streamer for the first award, with subsequent awards being a white star for placement on the streamer. At the moment only six of 14 Alabama chapters have presented a Flag Certificate, with the Wiregrass Chapter being one on the non-presenters. Certificates have been ordered, and we need to find a suitable recipient NLT 31 March 2001. Please keep your eyes open, as we want to discuss this at our meeting.

PRESIDENT'S NOTES

At the February Meeting several goals for the chapter were outlined for the upcoming year to include a challenge of a 15% increase in our chapter's membership. I certainly believe that this can be achieved, as many of us know individuals who are eligible to join the SAR. We cannot just expect individuals to show up and want to join; we, as members, must take the first step to explain some of the goals of the organization and encourage and assist potential applicants in submitting an application.

WIREGRASS COUNTIES

When working with prospective SAR member who lives here in the Wiregrass Area of Alabama, it becomes vitally important to remember some of the county line changes that occurred within this section of the state. Given that most people look at the 1850 Federal Census since it was the first such census which contained the actual names of individuals, one needs to know in what county to review. Further frustrations can occur when looking for a family on a later census. It might well appear that the family had moved out of the county, when in reality, they stayed put and the county lines were simply just moved around them. In 1819, the year that Alabama gained statehood, Henry County was formed. This was a very large county, with few white settlers, which stretched from its current position on the map all the way to the present Alabama-Florida Line. As the population grew, this land area eventually gave rise to the present day Barbour, Coffee, Covington, Dale, Geneva, Henry and Houston Counties and parts of Pike and Crenshaw Counties. In 1824 Dale County was formed out of Henry County along with land from Covington, Barbour and Pike counties. This early Dale County includes what is now Dale, Coffee and Geneva Counties. As more accessible county government was needed, Coffee County was formed in 1841 from a portion of Dale County. At that time the southern bounty of both counties was the Alabama- Florida line. This was followed in December 1868 with the formation of Geneva County out of the southern most lands of Dale, Coffee, and Henry counties. Finally, the baby county of the State, Houston County, was formed in 1903 from portions of Dale, Geneva, and Henry Counties. To add to some of this frustration, floods or fire has destroyed several of the courthouses in the area. Geneva County has records from 1898 forward but floods have damaged some of the 1898 – 1929 records. Coffee County records were destroyed in 1851 by fire and floods likewise have damaged some records in Elba. The Dale County Courthouse had a fire in both 1869 and 1884 destroying most of their records. This information was drawn from

several different sources, all with a slight variation in the land areas used to form new counties. It is believed this is a good representation of the sequence of events in the formation of the counties of the Wiregrass Area.

THE COLONIAL CHAPEL AT THE AMERICAN VILLAGE

The ALSSAR has begun a campaign to raise funds to name the inside front doors of the Colonial Chapel the "Patriot Doors" to honor approximately nine hundred Revolutionary war soldiers who later lived in Alabama.
